Abstract

WORKSHOP 2 BETTER WAYS TO MOVE, BETTER PLACES TO LIVE: SUSTAINABLE MOBILITY IN MEDITERRANEAN COASTAL AREAS TO WORK, STUDY AND VISIT

Abstract

Densely populated, very economically active and rich in natural and cultural heritage, Mediterranean coastal areas attracts masses of people to visit, study and work; and their ports receive most of the goods and resources for the European market. Developing sustainable urban transports has therefore become crucial to improve the quality of life.

Representatives of the MED Urban Transports Community will have the opportunity to share their results with members of the UNIMED's Euro-Mediterranean Academic Community as well as with partners of other Interreg MED Communities; to learn about innovative and replicable measures to improve sustainable transport in Mediterranean coastal areas developed on the field; and eventually to seek advice to overcome their challenges and ultimately improve their outcomes.

Started in November 2016, the Interreg MED-funded projects of the MED Urban Transports Community (UTC) have designed, developed and tested a series of tools to make the mobility in Mediterranean coastal areas sustainable in places such as touristic towns, ports and university campuses.

UNIMED looks at these Interreg MED projects as an opening for transfer to the southern shores of the Mediterranean.

Abstract

The international cooperation instruments made available by the European Union largely contribute to creating bridges among people and societies, reinforcing scientific dialogue, cultural cooperation, trust, and mutual understanding.

EU instruments play a crucial role in building stable and effective relations among European and Southern Mediterranean countries.

Academic communities, students, faculty members and administrators, have benefited from a wide range of programmes promoting cooperation, mobility, research, capacity building.

The activities undertaken by the Euro-Mediterranean academic community show the value of encouraging and supporting this work, while also seeking more synergies in the light of the current multifaceted dynamics and challenges.

Given the renovated commitment of the European Commission on cross-border cooperation over the 2021-2027 period, this workshop seeks to propose a reflection by the Euro-Mediterranean academic community on the relationships between European Institutions and the Mediterranean region, offering an opportunity for evaluation and revaluation of regional policies.

Abstract

Policies for the internationalization of university systems, both on the European side and on the Southern Shore of the Mediterranean, are looking with greater attention to the countries of the Asian continent, and in particular to the Gulf countries and even the Far East.

New perspectives of internationalization with the university systems of important countries, both from a geopolitical and economic point of view, are now a solid reality on both shores of the Mediterranean, which certainly still have potential for growth and consolidation.

The UNIMED Network already counts among its members Universities from the Gulf countries such as Oman, United Arab Emirates and Qatar. A very recent new membership from Yemen adds further value to this significant contribution.

Further growth in terms of collaborations and possible joint initiatives are also opening up towards the countries of the Far East.

The next edition of EXPO 2020 Dubai will certainly create further opportunities in this direction, almost as a natural link between East and West.

The aim of the workshop is therefore to explore which forms of collaboration UNIMED can and must undertake through its members in order to go beyond the well-established dynamics of EU-Mediterranean relations. This is also done in the perspective of a necessary diversification of the system as well as of the awareness of the strategic role that the countries of the Gulf and the Far East play in the increasingly advanced system of international university relations.

Abstract

Higher Education Institutions are continuously playing a crucial role as social facilitator and represent a space for dialogue and debate and can be identified as economic engines for the development of the country as well as the region. This is particularly true in some countries which are deeply affected by social, institutional and political crisis: affected by years of war and instability.

Universities are the place where new leaders are trained and from where a new intellectual vanguard can emerge. However Universities need to be supported and encouraged in this difficult, complex and long process avoiding to act alone and by searching to create effective partnership with diversified actors.

Following the 2017 workshop at the UNIMED General Assembly in Paris organized in cooperation with Istanbul Aydin University and the workshop on Higher Education in crisis prepared for the 2018 edition of the UNIMED WEEK IN BRUSSELS, UNIMED is organizing a public roundtable for comparing and find a common ground for cooperation between International Organizations and Higher Education Institutions.

Avoiding fragmentation is the first goal in crisis situations where the whole system must work towards the same goal rowing in the same direction. Representatives from Universities and Institutions operating in a crisis context will explain their needs, strategies and operational methodologies, in order to identify common paths with EU partners and representatives. A better and deep knowledge of the benefit of local societies and trying to identify future common actions by redirecting future programs for a more effective impact and a stronger sustainability.
